News from the Board of Supervisors

Once again the Board is pleased to have the winter season with its snow and ice behind them and to welcome Spring.

As the milder weather approaches the road crew is preparing to start on the major roadwork to be done during the year. As always, this will include the tarring and chipping of some roads and the paving others. Other of projects planned for the year include the widening of a section of Roberts Road and the installation of pipe at the intersection of and Roberts Scott Roads to improve drainage problems. Sections of Black Road will also be built up to prevent erosion and

help with the blowing and drifting of snow during the winter.

The trimming of trees and brush along roadways will continue. Residents welcome are to perform this task for themselves but are reminded that all bushes trees. and other foliage is to be cutback at least 2 feet from the edge of the road.

The Board requests that all residents be careful when driving in a "Work Zone" and that they abide by all road closures that may be posted.

The Board would also like to remind residents of an Ordinance adopted in 2013 that established limitations of activities with Township Rightof-Ways.

The Ordinance prohibits the constructing, planting, plowing, disposing of any material or disturbing of land within 6 feet of any Township cartway within or the Township right-ofway, whichever is greater. Please keep this in mind when beginning work on your Spring/Summer projects.

Municipal/County Taxes

In order to receive the 2% discount on your taxes, your payment must be postmarked no later than April 30th. In order to avoid a 10% penalty on your taxes, your payment must be postmarked no later June 30th.

Please note that all taxes **MUST** be mailed to Ms. Reeder at 165 Honeysuckle Road in Nottingham. The elected tax collector is the only person allowed by law to accept these tax payments. Therefore, **NO PAYMENTS CAN BE ACCEPTED AT THE MUNICIPAL BUILDING**.

ZONING MATTERS

In an ongoing effort to keep Little Britain Township's Residents informed, I continue to expand our lobby information center. In this area you will find items like:

- Recycling options for ag plastics to prevent environmentally unfriendly burning.
- Contact information for Planners who will assist individuals in preparing Conservation or Ag Erosion and Sedimentation Plans.
- Contact information for Planners who will assist individuals in preparing Nutrient Management Plans.
- Manure Management Plan Guidance Books that includes Manure Management Plan Workbook, Spreading Record Keeping Forms, Manure Application Tables, and Farm Mapping samples. This book provides detailed information to assist you in properly keeping track of the land application of manure on your property per the State Requirements.
- Timber Harvest Packets. PLEASE remember a timber harvest packet needs to be turned into this office prior to work beginning. If you will be crossing a stream or disturbing a wetland you will also need to provide this office with an approval letter from the Lancaster County Conservation District.
- Tenant/Landlord Rights and Responsibilities Manual. This 58 page book is packed with information for both tenants and landlords explaining fair housing, rental applications, lease agreements, pre-rental inspections of unit, tenant's & landlord responsibilities, renters insurance, security deposit, repairs, evictions, and much more.
- Information on grazing and pasture management, as well as, animal concentration areas.
- Common Complaint Contact List. This list provides the name, telephone number and title of the appropriate person to handle your specific complaint regarding a multitude of topics.
- Noxious Weed Control document. Per the Pennsylvania Noxious Weed Control Law individual landowners are required to implement control measures if any of the invasive weeds are found on their property. This single page provides a list of Pennsylvania's Noxious Weeds and contact information for the PA Department of Agriculture who administers the regulations. These individuals provide information on how to handle infestations, take complaints and answer questions.
- Flood Insurance hand-out. This three page document discusses the importance of obtaining flood insurance, who should purchase said insurance and disaster assistance. It exposes

misconceptions and dispels myths about flood insurance.

- Livestock and Poultry Mortality Disposal brochure. This leaflet provides valuable information on approved methods of dead animal disposal. We also have contact information for dead animal removal services.
- A brochure from the Lancaster County Conservation District entitled So You Have A Stream In Your Backyard ... Here's What You Need To Know... which provides information on stream health, do's and don'ts and natural movement.
- Meeting Dates.
- Hearing Notices.
- Little Britain Recycling information.
- Voter Registration Forms.
- Wakefield Ambulance Association "Vial of Life" bottles. Residents place important medical information and medication lists for all persons living in the house in the bottle. Place the bottle in the freezer and the magnet on the refrigerator. This way if an ambulance needs to respond to an emergency at your home all your important information is at your fingertips.
- The newest addition is copies of a newspaper article that appeared in The Chronicle on March 19, 2019. This article advises farmers that there is money available to assist them with conservation projects on their farm. The Alliance for the Chesapeake Bay is a nonprofit organization who has \$1.5 million in funding to assist farmers in the watersheds of the east and west branches of the Octoraro Creek. <u>Airbnb</u>


